

## **Guidelines for registration of Growers' Societies**

1. There shall be a Name of the Growers' Society with specific location of their Office with proper address. The Growers' Society will be registered by the Assam State Agricultural Marketing Board in the Name, Location and Address of their Office under the following further Terms and Conditions.
2. The constituent membership of a Growers' Society should not be less than 5 (five) and more than 20 (twenty).
3. There should be a General Body of the Growers' Society consisting of all constituent members and an Executive Body consisting of minimum 2 (two) members with a President and a Secretary.
4. The Growers' Society must have a constitution of their own.
5. The Growers' Society, after formation shall apply for registration to the Board in the prescribed proforma along with relevant documents through the Secretary of the respective Regulated Market Committee.
6. There will be no registration fee.
7. The Growers' Society should have an Account in any Branch of a Nationalized Bank operating in the respective Notified Market Area.
8. The Growers' Society shall pull the members' share of their produce to the nearest market yard established under Assam Agricultural Produce Market Act, 1972 for disposal regularly.
9. The Growers' Society shall submit a statement of their members' monthly farm produce, every month to the Secretary of the concerned Market Committee.
10. The Registered Growers' Society will be eligible for getting any kind of marketing support whenever provided by the ASAMB for the development of Agricultural Marketing in the respective Market Area.
11. 1 (one) copy photograph of the President and Secretary of the Growers' Society.
