 - (b) Requisite Earnest Money in the form of Bank Guarantee TDR/FDR/Bank Guarantee from a Nationalized/Schedule Bank.
 - (c) DD/Banker's Cheque/Pay Order of requisite amount payable towards the cost of Bid Document.
10. The bidders are advised to scan their technical papers at 100 dpi (in black & white mode) in "pdf" format for multiple pages with maximum file size of 25 MB. If numbers of pages exceed, the bidders are advised to create multiple files and upload the same in "Upload Additional Document" stage.
