In pursuance of the IFB No. ASAMB/ENGG/2555/2018/16 dated 07-09-18, a Pre-bid meeting was scheduled on 26<sup>th</sup> September, 2018 at 1-00 PM in the Conference Hall of ASAMB. The Chief Executive Officer, ASAMB & Chairman of the Tender Committee has instructed the Dy. CEO (Finance), ASAMB to conduct the pre-bid meeting due to his other official engagement at Dispur.

Accordingly, the Dy. CEO (Finance), one other member of the Tender Committee and the Assistant Executive Engineer (Ahmed) was present in the meeting on behalf of the Board. All together 4 (four) nos. of prospective bidders were present in the venue at the scheduled time. Welcoming all, the Dy. CEO (Finance), ASAMB had asked the contractors present if, they have any queries relating to the bid documents for the works for which the bid was invited. The prospective bidders had discussed about the bid documents but; did not raise any query on the same. As enquired by the Dy. CEO (Finance), Sri Bhuban Chandra Deka, EE i/c informed that no queries relating to clarification to the bidding documents have been received in given e-mail address. However, one application had been received from M/s Mechfab Engineering Industries Pvt. Ltd., Bamunimaidan, Guwahati wherein their Firm is registered under different departments but; not under ASAMB and requested the Board authority to amend the NIT, so that they can also submit tenders. In this regard, the Dy. CEO (Finance) has stated that in case of local competitive Bidding, only the registered contractors of the concerned department are allowed to participate in the tendering process in general. For amendment of such provision of NIT as requested, the matter need to be placed before Board for decision and that will take time. As the works listed in the NIT are under the Central Govt. scheme and to be completed in a time bound manner, the prayer of M/s Mechfab Engineering Industries Pvt. Ltd., Bamunimaidan, Guwahati can not be considered at this stage.

The Meeting was ended with a vote of thanks from the chair of the Dy. CEO (Finance).
